



As we navigate through this unprecedented time, we have implemented a number of health and safety measures based on guidance from health authorities, such as the Centers for Disease Control and Prevention (CDC), and appropriate government agencies.

For Club Members, their Guests, our Cast Members and partners, there are key things to know before arriving at Golden Oak Club.



## Face Coverings

Face coverings are required for Members, Guests (ages 2 and up) and Cast Members, including those who have received a COVID-19 vaccine. Please bring your own face coverings and wear them at all times, except when dining, swimming or actively exercising. You may remove your face covering while actively eating or drinking, but you should be stationary and maintain appropriate physical distancing.



## Physical Distancing

Physical distancing practices are required, including 6-foot distancing between parties, as well as physically-distanced furniture and fitness equipment. Experiences may be modified in order to reduce contact.



## Enhanced Cleaning

An increased focus on disinfecting and sanitation is requested. To help facilitate cleanliness, hand sanitizing stations have been added in key areas.



## Symptom Awareness

Members and Guests may not visit the Golden Oak Summerhouse if they are experiencing any symptoms of COVID-19 identified by the CDC at [CDC.gov](https://www.cdc.gov); or if they have been in contact with someone with confirmed or suspected COVID-19 symptoms, without completing a 14-day quarantine; or if they are under any self-quarantine orders.



## Temperature Screenings

Guests entering Golden Oak Summerhouse for the purpose of table-service dining will undergo a temperature screening prior to restaurant entry. Anyone displaying a temperature of 100.4 F or above will be directed to an additional location for rescreening and assistance. Those with temperatures of 100.4 F or above and those in their party will not be allowed to utilize Summerhouse amenities.

## COVID-19 WARNING

We have taken enhanced health and safety measures—for you, our other Members, Guests, and Cast Members. You must follow all posted instructions while visiting Golden Oak Summerhouse.

## COVID-19 SYMPTOMS

By entering Golden Oak Summerhouse, you are confirming that you and all persons in your party:

- are not experiencing any symptoms of COVID-19 identified by the Centers for Disease
  - Fever over 100.4° or chills
  - Cough
  - Shortness of breath or difficulty breathing
  - Fatigue
  - Muscle or body aches
  - Headache
  - New loss of taste or smell
  - Sore throat
  - Congestion or runny nose
  - Nausea or vomiting
  - Diarrhea
- have not been in contact with someone with confirmed or suspected COVID-19 symptoms without completing a 14-day quarantine.
- are not under any self-quarantine orders.

Members or Guests who cannot confirm all of the above criteria must not enter Golden Oak Summerhouse.

Before you leave home, be sure to check the temperatures of everyone in your party—including yourself—as an extra layer of precaution.

## ELEVATED RISK

All persons in Florida over age 65 and/or with a significant underlying medical condition are urged to stay home and to take such other measures as necessary to limit their risk of exposure to COVID-19.
